



Safety Rules and Regulations

Rules have been established for the safety of our guest, staff and neighbors.

Safety is our highest priority and we reserve the right to enforce these rules to avoid serious injury to persons or property.

Gun Handling Rules:

- The following shotgun gauges are allowed. 12, 16, 20, 28, 410 (All other firearms are not allowed)
- Keep guns pointed in a safe direction and NEVER point the gun at another person
- Keep gun open at all times unless in shooting stand
- Always keep your finger off the trigger while outside the shooting stand
- Never load the gun until you are in the shooting stand
- Never load more than two shells
- Absolutely no shooting outside the shooting stand
- Only one shooter is allowed in the shooting stand at a time
- Always unload the gun before leaving the shooting stand

General Rules:

- Always wear ear and eye protection while on the course or around the 5-stand area. This applies to everyone - spectators, staff, trappers and shooters.
- Only Tampa Bay Sporting Clays staff are allowed to adjust, move, clear or otherwise handle all clay target machines.
- The only shot size allowed are 7 1/2, 8, 8 1/2 and 9
- Alcohol or drugs are strictly prohibited on the course or 5-stand
- Stay on the designated course trails at all times
- Harvesting of any game is prohibited
- Tampa Bay Sporting Clays staff reserves the right to inspect and approve all loads
- Each squad is allowed one review pair per station and any excess targets will be charged accordingly
- Shooters must be at least 18 years old and hold a valid driver's license or with an adult to shoot at TBSC.
- No one under 18 years of age will be allowed to participated in BullsBlast.
- If you are in doubt about any rule or regulation, please consult a member of the staff or management
- Any and all damages to golf carts will be the responsibility of person who checks out the cart

**WAIVER AND RELEASE, AND INDEMNIFICATION, DEFENSE AND SAVE AND HOLD HARMLESS AGREEMENT
THIS IS A LEGALLY BINDING AGREEMENT. BY SIGNING THIS AGREEMENT, YOU GIVE UP YOUR
RIGHT TO BRING A COURT ACTION TO RECOVER COMPENSATION OR OBTAIN ANY OTHER REMEDY FOR
INJURIES TO YOURSELF OR YOUR PROPERTY ARISING OUT OF YOUR PARTICIPATION AT THE BULLSBLAST
EVENT NOW OR ANY TIME IN THE FUTURE.**

I acknowledge that I am over the age of eighteen (18) years. I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, state that I understand that the BullsBlast 2017 event I have chosen to participate in (the "Event") to be held at Tampa Bay Sporting Clays ("TBSC") is very hazardous in that loaded firearms and weapons are discharged and archery equipment and arrows are used, not only by myself but also by other TBSC Members, guests and visiting public. I agree to read and abide by all safety rules and regulations implemented by TBSC, and also I agree to assume any and all risks associated to and with the use of the facilities or participation in the Event, including but not limited to: the use and discharge of firearms, accidental discharge of firearms, use and shooting of archery equipment, and loss of personal property through misplacement, loss or theft while at TBSC.

I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, for the consideration of being allowed to participate in the Event, and for other valuable considerations, do hereby absolutely and unequivocally agree to waive, release, save and hold harmless University of South Florida, University of South Florida Foundation, Inc., TBSC, BullsBlast 2017, Philanthropy Partners, LLC, R.R. Simmons

Construction Corporation, Simmons Management Services, Inc., and the officers, directors and members of any of them, and any of their respective sponsors, agents, employees, instructors, assigns and successors in interest (collectively the "Indemnitees") from any claim, demand or liability (whether claimed by myself or another person or entity) which may arise out of any loss, damage, injury or death which I may sustain, as well as any theft, unexplained disappearance or damage which may befall my property accompanying me (whether while en route to, during participation in or during observation of the Event, and while en route from the event, or while on the TBSC premises) where any of the Event occurs, with the above use of facilities and services, even if any loss, damage, injury, or death which I may sustain, including theft, unexplained disappearance, or damage which may befall my property arises from the negligence of any of the Indemnitees. **I VOLUNTARILY ASSUME ALL SUCH RISKS FOR MY FAMILY MEMBERS, GUESTS AND MYSELF (and heirs, agents, assigns, beneficiaries, executors and administrators).**

I, on behalf of myself and all family members, agree to indemnify, defend and hold harmless the Indemnitees for any and all damages caused by my participation in the Event, use of the TBSC facilities, use of equipment, and discharge of firearms which would include, but not be limited to, damages or personal injuries caused by my negligence and/or the negligence of anyone else that I have brought to the Event and/or the TBSC facilities, and attorneys' fees and costs to defend any and all claims brought against the Indemnitees resulting therefrom.

The duty to defend is independent and separate from any duty to indemnify hereunder, and the duty to defend exists regardless of any ultimate liability of myself or any of the Indemnitees. My duty to indemnify and defend will survive until it is determined by final judgement that an action against the Indemnitees for the matter indemnified hereunder is fully and finally barred by the applicable statute of limitations and statute of repose.

I further acknowledge the right of the Event organizers and/or TBSC employees to immediately terminate my participation in the Event upon any failure of mine (or my guests) to fully comply with all TBSC or Event rules and regulations and/or the directions of TBSC employees or the Event organizers. I hereby state that I am under NO legal injunction that prohibits my owning, possessing, handling or using any of the firearms used in the Event. I understand that the Event will be photographed. I hereby consent to being photographed and to the use of my image to promote BullsBlast on either the TBSC, USF or the Philanthropy Partners, Inc. websites, social media and/or published materials related to this Event or future BullsBlast events.

By my signature below, I certify that I have read, understand and agree to the terms and conditions of this Waiver and Release of Liability. I acknowledge that this Waiver, and Release, and Indemnification, Defense and Save and Hold Harmless Agreement is intended to be as broad and inclusive as permitted by the law of the State of Florida and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. I understand that the terms of this Agreement are legally binding and that I am signing this Waiver and Release, and Indemnification, Defense and Save and Hold Harmless Agreement after having carefully read it, of my own free will.
